# The new legislation is coming at a huge cost

CCPA is coming, bringing with it legal updates that must be executed across multiple departments of your organisation.

GDPR already caused a huge endeavour for companies doing business with the EU, they were faced with large numbers of legal updates across many areas of the business. But that was just the beginning - legal updates will keep coming, such as the California Consumer Privacy Act (CCPA), which will impact many areas of your business, including every document your company uses.

Manually updating these documents is vitally important, but also can be a nightmare for admins and IT support.

According to a TrustArc <u>survey featured by TechRepublic</u>, 88% of respondents say they need external help to understand what exactly they need to do to get in line with the CCPA.

These external costs, such as legal advice and technical consultations, can quickly stack up, especially when there are numerous manual stages to the updating process.



# Difficulties of maintaining legal compliance

Every document template containing legal information will need updating, which is a slow, manual, inefficient and expensive process for most companies.

Some legal updates will impact every document used in your company, and manually updating these is a nightmare for admins and IT support. This hits the business and the departments responsible.

Maintaining legal compliance is perceived as strenuous, due to ineffective and cumbersome processes and technological fixes. Major legal changes present extra expenses, such as hiring consultants and external services to ensure compliance, which can cost millions of dollars.



#### **Limited resources**

Updating document templates is a specialist job, and there is often a backlog with the necessary teams, for example, IT maintenance.



#### **Outdated processes**

Manually updating legal changes across every document template is a slow and ineffective process, prone to human error.

# Mitigate risk with centralized document automation

Document automation tools are an integral part of any enterprise tech stack, especially with major legal changes on the horizon.

Every document used by companies contains legal risk. 


